## NORTH PENN SCHOOL DISTRICT SCHOOL BOARD REPORT NOTES FROM THE LAST BOARD MEETING #1044

An Action meeting of the Board of School Directors of the North Penn School District was held at the Educational Service Center on Thursday, December 17, 2015.
