SCHOOL BOARD REPORT

NOTES FROM THE LAST BOARD MEETING #995

The monthly meeting of the Board of School Directors of the North Penn School District was held at the Educational Service Center on Thursday, May 17, 2012.

The meeting was called to order by Vincent Sherpinsky, board president, at 7:30p.m. Vincent Sherpinsky reminded those in attendance that the meeting was being videotaped by the school district for the community cable channel.
